1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

P. D. Karkhanis College of Arts & Commerce, Ambarnath is an affiliated college under the University of Mumbai. It was established in 1986 by The Education Society, Ambaranth with co-education system.

Shri. Bhausaheb Paranjape, Gandhian philosoper and an eminent social worker with his associates established The Eduication Society at Ambarnath in 1936 as a charitable trust with luminaries Shri. Limaye, Shri. Kolkar, Shri. Chhaya, Shri. Devasthali, Shri. Kunder. The Society is registed under Trust Act and as a society under Society's Act with following objectives as laid down in the constitution of the society.

- 1. To provide educational opportunities right from pre-primary to higher education to the students of Ambarnath and its vicinity.
- 2. To provide Physical, Industrial and Technical education.
- 3. To merge institutions having above objectives of education on suitable terms.

Shri. Bhausaheb Paranjape a profound visionary with a mission guided by Gandhian philosophy was the General Manager in Dharamsi Morarji chemicals, Ambarnath, realising that mejority of the citizens of Ambarnath could not afford education to their wards outside Ambarnath being economically poor and socially backward, it was necessary that these wards get education in Ambarnath itself and with this feeling, he established the trust's high school known as Mahatma Gandhi Vidyalaya, Ambarnath (West).

After experiencing the difficulties of crossing the railway line, the Society opened its classes in East side in 1971 and gradually converted into an independent school since 1978 named as Kansai High School which is now named as Bhausaheb Paranjape High School.

Off late with the introduction of 10+2+3 pattern of education, +2 was started with all the three streams of Arts, Science and Commerce in the high school run by the Education Society, Ambaranth.

The agony was not over as students of Jr. College run by the school were finding to get admission in the +3 degree college in the vicinity prompting the need to start degree college in Ambarnath.

Accordingly during the Golden Jubilee of year of The Education Society in 1985, it was decided to seek permission for Degree collge. The University was kind enough to realize the need and recommended to the Government of Maharashtra to grant permission to the society to start a full fledged Arts and Commerce College at Ambarnath. The Government of Maharashtra too realized the same and granted permission in June 1986 and in the very month, the college came into its existence.

1.3 CRITERIA WISE SUMMARY

Curricular Aspects

- The Education Society's P. D. Karkhanis College of Arts & Commerce, Ambarnath is permanently affiliated to University of Mumbai, Mumbai. College has got 2f & 12b recognition from UGC.
- Being an affiliated college there is no autonomy to design and redesign its own courses. However one of the faculty member was on the Board of studies. In addition some of our faculty members indirectly contribute by attending seminars, workshops organized by the University for the purpose and communicating their suggestions for restructuring of the syllabus.
- The faculty members are briefed on the academic activities of the college on the first meeting of the commencement of every academic year. The Head of the departments arranges departmental meetings to distribute and assign the workload. Considering the workload and planning held in the departmental meetings, the syllabus is disseminated as per classes and papers for teaching.
- Each teacher is provided timetable, workload, Semester teaching plan, actual teaching units and academic and administrative committee responsibilities.
- The timetable committee prepares a general time-table and HoD of concerned departments prepare departmental timetable. Teachers conduct classes according to the timetable. IQAC reviews the syllabus completed.
- Considering use of ICT in the higher education, the various electronic applications such as Google Classroom, Google Meet, Zoom, what's app, Telegram etc. are being commonly used along with the traditional method in teaching learning process. Along with this, experiential learning, participative learning with the help project work, assignment, seminar, PPT, activities are carried out to make teaching learning process effective. Besides the guest lectures are arranged to enrich the effective

curriculum delivery.

- The College ensures effective curriculum delivery through a well-planned and documented process. The IQAC prepares the academic calendar of the college and also the concerned departments prepare their departmental academic calendars prior to the commencement of every academic year. The academic calendar specifies suitable available dates for significant academic and other activities.
- For smooth conduct of Examination: Question papers are set by concerned teachers of every department for all programs being offered; a copy of the question papers are submitted to the examination committee. Students are assessed on the basis of the semester end examination, Tutorials, Project work etc.
- The College has conducted 10 value added courses during the assessment period.
- Institution integrates various crosscutting issues relevant to professional ethics, gender, human values, environment and sustainability.
- 75.51% of students have completed projects in the last completed academic year.
- The feedback on curriculum is collected and analyzed from different stakeholders including students, teachers and alumni.

Teaching-learning and Evaluation

Teaching-learning and evaluation is a continuous process through which the College tries to meet academic excellence. The area where our college is located is an industrial estate. Majority of the students in the college are the children of industrial workers as well as educationally, socially and economically disadvantaged sections of the society. The aim of the college is to bring such backward and disadvantaged students into the stream of higher education. The teachers in the college encourage students to participate in the process of education through seminars, group discussions, project work, study tours etc. through the process of teaching learning - and evaluation. Many of our teachers are Ph.D & one is Ph.D guide. The teachers also provide counseling to the Slow Learners, also provide special attention through measures like Remedial Coaching. Transparency is ensured in the fully automated admission process through adherence to University and State government rules. The institute accelerates and ensures effective teaching-learning process by providing LCD projects, computers with internet facility etc. It also encourages college teachers to attend conferences, seminars, workshops and research programs to update their knowledge. As a result most of the teaching staff in the college today are Ph. D. holders, & remaining all the teachers have registered for Ph.D and their research work is in progress. The Credit Based Grading System prescribed by the University of Mumbai helps in continuous evaluation of students through project work and university semester examinations. The performance of the students in examination is accepted as feedback and efforts are made to improve the performance of the students.

Research, Innovations and Extension

P. D. Karkhanis College is advancing with ideas of establishing an ecosystem for nurturing innovation through various workshops, guidance sessions on research methodology, entrepreneurship and IPRs. It promotes the research culture among the teachers and the students.

There has been resource mobilization for research from government bodies. Two teachers have received

research grants, i.e., UGC travel grants for presenting papers at International Conference and another faculty completed RUSA funded Seed Money Minor Research Project. Students are encouraged through various workshops and seminars to take up small research projects and for participating in intercollegiate research paper /article competition. IPRS and entrepreneurships awareness workshops and guidance sessions are also organized to promote innovation among the youth.

Faculties have published a total of thirty nine research papers in UGC notified journals and twenty four in national/ international conference proceedings during the last five years. A total of fourteen books have been authored and co-authored by three faculties of the college.

Our Institution has received awards and recognition for its active engagement and involvement in extension activities from twenty Government and Government recognized bodies. During the last five academic years the staff and students of the Institution has enthusiastically participated in various extension activities for holistic development of community.

P. D. Karkhanis College carries out various extension activities in the neighbouring villages and surrounding urban region. Our extensions wings i.e., DLLE, NSS and WDC & Vivekvahini are working towards quality enhancement of learners and community. Students are involved in community work. It helps to pass on the values of gender equality, patriotism, sharing and caring, brotherhood, girls' education, environmental protection, water conservation, plastic ban and values of cleanliness.

Swachhata Abhiyan/Pakhwada –Our extension students as well as non -extension students take part in campus cleaning activity regularly. Tree Planation & Preservation activity, Blood Donations Drives, Best out of waste, Awareness Rallies and Skit are our regular practices.

In Addition to this, through various types of competitions i.e., essay writing competition, elocution competition and, Rangoli, Poster making and singing competitions students are given a platform to foster their integrated development.

Thus, we are extending helping hand to needy people in the vicinity and living its mottos of not me but you and reach to unreached.

Infrastructure and Learning Resources

The college is situated in at ground floor plus three floors. Campus has spread over an area of 3.15 acres. College runs YCMOU Nashik study center located on the ground floor next to the NSS room. There is a well-equipped gymnasium in the spacious premises of the college. Sports and sports infrastructure includes multipurpose indoor courts for chess, carom, table tennis etc. Outdoor sports like Cricket, Kabaddi, Kho-Kho, Badminton, Holly ball etc. The fitness and wellness facilities include gymnasium and yoga room etc. There is a computer room on the 3rd floor which has a total of 21 computers for students to surf. Uninterrupted power supply is ensured in the campus. 4 KV inverter in administrative office, 800 watt inverter in library and IQAC, and 800 watt inverter in exam room. 37 computers have been provided with internet facility. There is 20 Mbps internet professional line connection for college administrative facility. The seminar hall has ICT facility with projector. Knowledge Resource Center with an area of 4018 square meters which is partially automated with soul software from 2019-20. The library has a total of 14071 books, 7 journals and periodicals, 68 CDs, 10 maps, 1,99,500 e-books and 6000 e-journals N-listed.

During the assessment period, the average percentage of expenditure incurred on enhancement and maintenance of physical and educational facilities was 9.3% and 34.4% of the total expenditure respectively.

The college has adequate infrastructure for academic and extra-curricular activities. New facilities are added to meet academic standards and existing facilities are regularly upgraded.

Our students are working as Charted Accountant, Advocates, Journalist ,Lecturers,Bank Manger,Ralway officer,Teachers.One of our student has cleared the SET Examination. Though our almuni association is not regirstered but every year our one meeting of almuni association is conducted. There is continuous communication in between teachers and almuni. Our students are very active in sports and cultural activities. Many of our students have got not only university/state/university level certificates but also at international leve.

Institutional preparedness for NEP

1. Multidisciplinary/interdisciplinary:

P. D. Karkhanis college established in the year 1986 with an objective of providing higher educational facility to working youth from the economically weaker sections in the region. At present, the College offers Bachelor of Arts (B. A.) and Bachelor of Commerce (B.Com.). The College also offers Certificate Course in Web Developer, Domestic Data Entry Operator, Women's Studies with collaboration National Skill Development Corporation (NSDC), Pradhanmantri Kaushal Vikas Yojna. The College is situated in the Ambernath Thane region in the vicinity of Mumbai city Maharashtra state, which is developing rapidly in terms of industry, commercial centres and infrastructure offering innumerable

opportunities for introducing new multidisciplinary and interdisciplinary courses in collaboration with industry. Industrial and commercial developments in the region will provide opportunity to the College to avail necessary teaching staff for new courses as per the National Education Policy, 2020. In conclusion, it can be said that the College is ready to grab the opportunities offered by the National Education Policy, 2020 by offering several certificate courses, diploma and advanced diploma and degree programmes as per the needs of the local society. 2. Academic bank of credits (ABC): Academic Bank of Credit is the soul of National Education Policy. It is a repository of credits accumulated by students at various stages of their academic journey at the UG and PG level. The repository will facilitate movement of students from one discipline to other discipline, from one institution to other institution and from one course to other course. The student will also have a convenience of multiple entries and multiple exits. University of Mumbai given the whole of NEP & ABC mechanism and its registration process. Almost 40% of the College students have already downloaded digilocker and registered on the ABC portal. 3. Skill development: 3. Skill development as per the National Skill Qualifications Framework (NSQF) is an essential component of higher education system, as it helps students develop the practical skills they need to succeed in their careers. The College offers several skills orientated certificate courses to develop employment skills and provide job opportunities to the students. Under the NEP framework, the College proposes to offer specialized training programmes in the fields of Banking, Accountancy, Insurance, Advertising, Logistics, Supply Chain, E-commerce and so on to develop soft skills and technical skills of students. These courses can help students develop

highly sought-after skills that are relevant to specific industries. The College also proposes to develop entrepreneurial skills of Commerce graduates to promote new start-ups in the field. Under the National Education Policy, the College proposes to enter into formal MOUs with industries in the vicinity to provide job opportunities to students on their graduation or post graduation.

4. Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course):

As a step in the direction of the furtherance of the goals of the New Education Policy, the College is well-equipped in terms of human resource and infrastructure to offer courses in languages such as Marathi The ancient Indian education system has made significant contributions to various branches of knowledge. Some of the examples of the same are: (1) Accounting and Bookkeeping: The ancient Indians developed sophisticated systems of accounting and bookkeeping, which were taught as part of the education system. This included methods for recording transactions, maintaining ledgers, and calculating profits and losses. This knowledge helped in resolving disputes, ensuring fair trade practices, and regulating commercial transactions. (4) Financial Instruments: The education system emphasized knowledge of financial instruments, such as hundis (bills of exchange), promissory notes, and loans. These instruments facilitated trade and financial transactions. It is important to note that these contributions from the ancient Indian education system laid the foundation for modern practices in commerce, banking, and finance. While contemporary knowledge and practices have evolved significantly, the roots of many concepts can be traced back to the rich heritage of ancient Indian education and intellectual contributions. The College will include these contributions to the compulsory course in Indian Knowledge System of 2 credits under the New Education Policy.

The College will implement OBE system as per the framework prepared by the University of Mumbai

methods. To make classroom teaching more student centric various strategies are adopted by the teachers. In the subject of Foundation course & Environmental studies various videos on various topics in the syllabus explaining the syllabus practically are shared online in the classes of the students. At the beginning of the year all the departments plan their activities. Under experiential learning Bank visits /SEBI visits are organized by the commerce and department of economics. Economics dept. organizes bank and mutual fund Visits to show the functioning of the banking & how a bank functions, similarly functioning of the mutual funds is shown to the students directly. History dept. organizes historical tours to important historical places like fort of "Raigad" where king Chatrapati Shivaji Maharaj was borned. Such historical tours are organized to experience history directly. Marathi dept. organizes the program in which poems are presented by the students which are made by the students. Various poets and writers are called to guide to the students about how to make poem, novel, autobiography, articles etc.. Sociology dept. organizes the programs in which students prepare foods like vada pay, samosa, & other famous foods and they sell at college. Organization of jewellery making workshop by the commerce dept. teaches to the students about how to prepare jewellery. Hands-on training on Computers for first generation learners, plant propagation techniques etc. These activities enable students to learn soft-skills related to their curriculum. In today's competitive market there is competition to get the so job interview techniques are taught and personality development programs are arranged. Rangoli competition, poster making competition, best out of waste competitions are organized by the Art circle, DLLE, and NSS, Vedic Mathematics techniques are used as one of the problem solving tools for mathematics. Response:

College being affiliated to university of mumbai, all the norms announced and declared by the university of Mumbai in the context of internal/external assessment are followed and implemented by the college. Also grievance redressal system is time-bound and efficient. IQAC prepares academic calendar which includes continuous internal assessment. The same is displayed on the college notice board as well as on website. At the beginning of the semester to make students aware orientation program is conducted. Evaluation procedures are included in teaching plans. SMS facility is used to send important messages to the students and their parents.

Group discussions, Seminars, and guest lectures are conducted regularly. Assignments are given to students to improve their writing skills. Topic wise question banks are provided for all subjects. Unit tests are conducted as per the requirement of the concerned syllabus of different classes. As per the university pattern tests are prepared and conducted. Students are encouraged to solve previous years' University Examination question papers.

College is having a transparent and robust internal assessment mechanism in terms of frequency & mode. At both the semester levels foundation course paper has 20 marks projects to fybcom/sybcom/fyba/syba classes. About 8 to 10 Topics for the project are given by the concerned class teacher. Students choose anyone of these 8 to 10 Topics & submit project to concerned teacher. After submission of the project viva-voce is organized on a particular date in which student present their topic in front of the teacher & students. Similarly in the subjects of History/Economics/Marathi two papers are having projects having 20 Marks. Absent students in the projects and Viva voce are given a new date for submission. 02 to 03 times new dates are declared & given for project submission to absent students. Tutorials are given to students in the subjects of the Communication Skills & Mathematics. In each subject monthly test is conducted. Results of the internal tests are declared in the class & students continuously are promoted to improve their performance in the test. The list of the defaulters are declared in the case of each subject in this manner every teacher tries to increase the attendance in the class. Daily attendance of the students is marked, and daily records of lectures are taken &maintained.

As per the guidelines of university of mumbai redressal of grievances is done. At the college level. These guidelines are common for the college and university. At the College level, such cases are addressed to the Examination Committee and unfair means committee resolves within a maximum period of 15 days promptly and confidentially.

All the students fill up the examination form, Hall tickets are issued. If there is any discrepancies in the name of the student and subject then student register grievance to Examination committee. These grievances are resolved within the period of maximum 15 days. For rechecking the marks of the paper a student has to fill up a form and to submit. Examination committee checks the papers for any unassessed questions or for totaling errors and takes necessary action, if any correction is required. The corrected mark list is handed over to the student within the stipulated time.

The extracurricular activities such as NSS has made able our students to achieve many awards and grades.

Teachers & students are aware of the stated programme & course outcomes of the programmes offered by the institution. On the website of the college program outcomes & course outcomes are published every year. Under a particular link all the outcomes are published. The link of the college website is given to all the students. Students easily can go to college website where they get program & course outcomes. They can read & understand all these outcomes. At the time of admission every faculty guides

about outcome in their programme and courses. At the beginning When a student is taking admission to Arts /Commerce faculty at that time concerned faculty guides him/her about outcomes of Arts/Commerce faculty so that it can choose anyone of both faculties as per its choice. The lab have internet of 25 Mbps bandwidth and WI-FI connectivity.

Seminar Hall with ICT:

The seminar hall has been upgraded with the latest ICT for smooth conducting of workshops, conferences, guest Lectures and seminars etc.

Library:

The Library has an Advisory Committee and is headed by the principle to look into the smooth and efficient functioning. It has 10,299 Text-books and 1462 reference books. It has access to more than 17 thousands CDs & Videos. The library is equipped with E-Library software. After the admission at the college library cards are issued to students, which will be valid till their final semester. The library is under CCTV surveillance.

Facilities for culutural activities:

On an average, more than 25 cultural activities are conducted annually. There is an open theater and auditorium for thetrical presentation in the campus having approximate area is about 44.6ft.length and 29.3ft Width Respectively. Practice sessions of cultural activities such as plays, skites, flok dance, one act plays, singing, lawani, solo dance, Gondhal geet etc. take plays in these theaters. A cultural committee led by a senior faculty looks after the need of infrastucture.

Gymnasium:

The institution has an academic calendar where tentative dates for games and sports and other cocurricular activities are fixed. Students participate in various outdoor games, indoor games, and sports during annual sports organized by the Gymkhana comittee. Students and Teachers participate in friendly cricket match organized by the Gymkhana comittee every year. Response:

The library of the college was started in 1986,and since then it has made consistent progress in terms of collection of books,periodicals,e-sources and services. The college library has furnised building of 4018sq.ft mt.area. It provides open accesss facilities which help in easy access and use of the library as a learning knowledge centre which has been partially automated. Since the college is in the morning session, the reading room is available for the students after 10.00 a.m. The college has very enriched library in terms of availability of reference books and textbooks. The library has a total of 10,299 text and 1462 reference books.

The library is automated with integrated library management software SOUL 2.0 (Software for University Libraries) of INFLIBNET .The various housekeeping activities of the library such as data entry, issue and return and renewal of books, members login etc are done through the software. Service is also provided where the users can search the collection of books by tittle, author, publisher etc. The books are being bar coded and the users are given unique barcode ID. Apart from the printed books the library is having access to e resources of n list which is a part of e- shodhsindhu consortium of INFLIBNET, where the users are given awareness and made to access browse and download e- books, e-journals, database etc. The new books are displayed for two weeks on display stand. User orientation is provided at the beginning of the year regarding the various facilities & services and resources available in the library.

The Internet facility is provided with all systems with 10Mbps. For Enhancing security 24 closed circuit cameras have been installed.

The library is automatetd, and has a spacious reading hall and reference section. The reading area can accommodate 100 users at any time.

IQAC conducts a meeting regarding this, and guidance is provided regarding the terminology used in the form. Every staff member submits PBAS form, after calculating their Academic Performance Indicator (API) using Teacher log book/diary. The form, the Log book and the copies of other documents in support the claims, are submitted to the HOD for verification and validation. The form approved by HOD is then forwarded to IQAC. IQAC Verifies and validates API points and recommends the case to the University through the Principal after ensuring that the staff member fulfils all prescribed conditions and has become eligible for PBAS / CAS. The affiliating University appoints Panel/Committee for CAS, which again verifies and validates the API scores claimed, based on documents and personnel interview. The Panel/Committee, then recommends the case to the Joint Director, Higher Education Government of Maharashtra, for Pay and Grade fixation. After the declaration of results of Examinations, the performance of Teachers is evaluated on the basis of subject-wise and teacher-wise result analysis. 6.4 Financial Management and Resource Mobilization

6.4.1

Response:

The institute conducts regular financial audits. The institute has a formal mechanism for internal and external audits. The accounts are regularly audited to ensure financial compliance. College conducts both internal and external financial audits on regular basis. College Management believes in continuous monitoring of financial aspects of the college. The institute has the budgetary control system to monitor the effective and efficient use of financial resources. Many reforms were brought in the financial administration of the institution. Financial committee headed by the principal and representations of the management, teaching staff and administrative staff will be sought budgetary requirements from various departments and cells. At the beginning of the academic year the annual budgets are prepared, reviewed and approved by the finance committee. The finance committee has fixed the limits of total recurring and non-recurring expenditures based on the income and resources of the institution. The institute regularly follows internal and external financial audit system. The institutional accounts are audited regularly by both internal and statutory audits. Qualified internal auditors have been appointed and a team of staff under them verify all vouchers of the transactions that are carried out in each financial year. The internal auditor shall evaluate and confirm the effectiveness of internal system of accounting of the receipts. The internal auditor should verify that the fees are collected from all the students and if there is any concession, the same is granted by a person who is so authorized. The internal auditor should also ensure that the fees received in advance and fees receivable are properly accounted and irrecoverable fees are written off under the authorization of the appropriate person. So far there has been no major objection in financial auditing, minor errors or omissions when pointed out by the audit team are immediately corrected / rectified and precautionary steps are taken to avoid recurrence of such errors in future. The auditor verifies the income and expenditure details of the college as per the balance sheet.

Two teachers have received research grants, i.e., UGC travel grants for presenting papers at International Conference and another faculty completed RUSA funded Seed Money Minor Research Project.

Faculties have published a total of thirty- nine research papers in UGC notified journals and twenty- four in national/ international conference proceedings during the last five years. A total of fourteen books have been authored and co-authored by three faculties of the college.

Management augmented research infrastructure in the form of extensive library facility, NLIST and other e-resources.
